REQUEST FOR PROPOSALS Faculty Grants for the Development of Service-Learning Courses Special Focus: Faculty Mentor

CommunityEngagement@Wayne invites proposals for teaching innovations and new research initiatives from Wayne State University faculty and graduate teaching assistants. The proposed projects should advance the CommunityEngagement@Wayne mission to engage students, faculty, and community members in learning together through service and civic participation in a diverse, democratic society.

Funding for teaching should enable faculty/graduate teaching assistants to engage students in course projects that involve community partners and address important community or civic issues and/or develop curricula or courses that strengthen community service-learning or civic education. For this Faculty Grant, an additional stipend is provided for a faculty mentor. The applicant for this grant should identify a WSU faculty member who has previously taught a service-learning course; please see CommunityEngagement@Wayne if you need help identifying an experienced mentor. The mentor will assist the applicant in course preparation and planning as well as be available to consult with the applicant during the teaching of the course.

Funding for research should include projects that give students exposure to and involve them in community service or civic engagement through community-based research projects.

Grants up to \$2,000 are available to individual faculty members/graduate assistants. An additional \$500 will be provided to the faculty mentor. Projects/courses should have an expected start date.

WHAT IS SERVICE LEARNING?

For the purposes of this grant, service learning is a method of teaching by which students learn by applying classroom experiences to real-life situations at a specific community site. Such courses:

- meet a need identified by a community partner;
- are coordinated collaboratively by a faculty member and the community partner;
- integrate the service-learning experience into the academic component of the course;
- provide structured time for students to reflect on and write about their service experiences before, during and after they occur.

ELIGIBILITY

Funds are available to continuing instructional faculty, lecturers, and graduate teaching assistants at Wayne State University, as long as a commitment that the integrated course will be taught within the next year (by Fall 2011) can be made. Those selected will receive \$1,500 for course planning and execution and \$500 after teaching the course and submitting a CD containing final student projects; explanation of impact, preferably in Powerpoint format, that illustrate the connection between specific experiences in the Detroit area community and the learning objectives of the course

Priority will be given to faculty who previously have not received funding from CommunityEngagement@Wayne and/or involved their students in community service and civic engagement.

Qualified applicants must agree to all of the following:

- Schedule a Lunchtime Discussion presentation or present at a CommunityEngagement@Wayne event within one calendar year after the class has been taught
- Submit a short article about your class and service experience to be published on CommunityEngagement@Wayne's website and blog site
- Post relevant student products (e.g. oral histories, pictures) on the Living Detroit website

Mentors must agree to all of the following:

- Present with the applicant at a Lunchtime Discussion or at the CommunityEngagement@Wayne event within one calendar year after the class has been taught
- Meet regularly with the applicant during the course preparation period and agree to be available for consult during the teaching of the course
- Provide the applicant with sample syllabi, teaching strategies, readings, and any suggestions and materials that will aid the applicant's implementation of service-learning pedagogy and best practices.

APPLICATION PROCESS

Proposals are accepted on a continuing basis. Award decisions will be announced one month from proposal receipt in the office of CommunityEngagement@Wayne.

A proposal application should include:

- 1. Completed cover sheet (use form below).
- 2. Project Summary or Abstract
- 3. Proposal narrative of 5 double-spaced pages or less that addresses:
 - Course description and rationale. Briefly describe the course its significance, objectives and scope and identify community partners. Highlight any features of the course that would make it especially appealing to students. If a graduate student will be involved in designing and/or teaching this course, describe his/her role.
 - Impact. Describe how the course will accomplish learning objectives; develop knowledge, skills, attitudes and experiences to help students address the issue. Provide a sample course project related to the course theme. How many students are expected to take your course?
 - Plan of operation. Document a realistic timeline for identifying and working collaboratively with a community partner, developing course projects, and managing student involvement in the community site during the semester. If you need assistance in identifying a community partner, please contact the CommunityEngagement@Wayne prior to submitting your proposal.
 - Plan of evaluation. Describe how student projects will be evaluated in the class and in the community.
 - Future plans. Describe your expectations for offering the course in your department beyond the period of funding.
 - Supporting information. Attach your CV, mentor's CV, and, if available, letters of interest from your potential community partner(s). (This material is not part of the 5-page narrative.)

SELECTION CRITERIA

Grants will be awarded based on the proposed project's fit with CommunityEngagement@Wayne's mission, as well as:

• Quality and extent of expected student civic and community service-learning outcomes

- Quality and extent of potential community impact
- Potential impact on the faculty and students' continued involvement in community service, learning, and civic engagement

GRANT REQUIREMENTS

Successful applicants will need to:

- Attend one meeting of grantees during the academic year to assist with planning future CommunityEngagement@Wayne initiatives
- Submit final products within 45 days of project conclusion
- Submit one PowerPoint slide that can be posted on the CommunityEngagement@Wayne website to describe the project; and
- Present at a Lunchtime Discussion during the next semester to share work
- Teach the class next available semester
- Agree to sustain class for an additional semester (subject to departmental approval)

Mentors will need to:

- Present with applicant during the next semester
- Submit a brief statement describing the course preparation process


